1.	I have purchased tickets to the Theatre Calgary production of "Iceland" and desire to be seated "onstage" in the seating levels located behind the set.	mitais
2.	I have read this Agreement and I am familiar with its terms. I understand that being seated "onstage" in the seating levels located behind the set involves many inherent risks, dangers and hazards, known and unknown, including but not limited to: the "onstage" seats may be elevated and present a fall risk; the "onstage" seats are accessed via stairs and such access may present a fall risk; and the "onstage" seats may present other hazards, as identified in the safety briefing from stage management personnel or other Theatre Calgary employees prior to the start of the production. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death or loss resulting therefrom.	
3.	 In consideration of the Releasees permitting me to attend the production of "Iceland" and be seated "onstage" in the seating levels located behind the set, I hereby agree as follows: (a) to abide by all instructions, directions and orders given to me by stage management personnel or other Theatre Calgary employees, and to take proper care and precaution at all times before, during or after the performance while on Theatre Calgary premises; (b) I am entering the Theatre Calgary premises and being seated "onstage" at my own risk; (c) to waive any and all claims that I have or may in the future have against the Releasees and to release the Releasees from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my entering onto the Theatre Calgary premises to attend a performance of "Iceland", due to any cause whatsoever, including negligence, breach of contract or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers' Liability Act (Alberta) on the part of the Releasees, and further including the failure on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers and hazards of entering onto the premises of Theatre Calgary to attend a performance of "Iceland", including such risks, dangers and hazards as those referred to above; and 	
	(d) any injuries incurred are the responsibility of myself, and not of the Releasees.	
4.	This Agreement will be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.	

I confirm that I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of entering onto the premises of Theatre Calgary and with respect to the safety of being seated "onstage" in the seating levels located behind the set. I confirm that signing this Waiver of Liability is a precondition to being seated "onstage" in the seating levels located behind the set. I confirm that I have read and understood the Agreement prior to signing it and I am aware that by signing this Agreement, I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, assigns and representatives may have against the Releasees.
